4. PRESENTATION

Dawn MacNeill's, Watershed Planner from NS Environment will be presenting:

“Due Diligence and the 5 Step Process for Source Water Protection”

- NS Drinking Water Strategy “Multiple-Barrier Approach” keeping source water clean and safe, an industry wide accepted approach.
- The first barrier is keeping the source water clean with a source water protection program, other components of the approach are water treatment, operator certification, and continuous monitoring of the water going through the distribution system.
- 79 water supplies in the Province of Nova Scotia, split between surface water and ground water supplies, which all require source water protection plans. 23 of the water supplies are designated protected water areas.
- 60% of of Nova Scotians served by Municipal water and the other 40% are on private systems.
- Due Diligence means taking every reasonable precaution to the extent of your ability and authority to do so.
- Every Water Utility in the province needs to have a: Contingency Plan, Source Water Protection Plan, Certified Operators, Water Testing Reports. Approvals to Operate and Approvals to Withdraw. the utility has the responsibility to meet the terms and conditions of the approvals to operate, which includes meeting drinking water standards. Testing must show, you meet the guidelines for Canadian drinking water quality by reporting exceedances, corrective actions and report regularly on the water quality.
- Asset Management Plan includes the Towns Water Infrastructure
- Water Operators are continually taking course to get their CEU's
- January 2019, NS Environment required that the Water Utility Sampling Plan be updated.
- The Town does have processes during construction projects to prevent cross contamination of water, but not a Cross Connection Program document.



- Discussed the ABC's of Source Water Protection re: A = *Acquisition* of Land (controlled land use), B's = Municipal Land Use *Bylaws, Best Management Practises*, C = Plan for any type of *Contamination*. D = *Designation* of a protected water area, designation regulates activities that may impair water quality, (designation not the same as a protected area re: Nature Trust), E = *Education* and awareness programs.
