  a lounge at full capacity. Currently there are two licenses as part of the restaurant an eating
  establishment license and lounge license
- The current Development Agreement which is set by the MPS restricts lounge seating to 50 seats inside and 20 seats outside on the patio, and these numbers are well below overall capacities



 Hosting a World Class event like Devour! and not being able to host events is limiting the ability of Wolfville becoming a Culinary destination

## b. Lightfoot & Wolfville Vineyard, Michael Lightfoot

- Lightfoot & Wolfville vineyards is working to create a culinary destination
- At the start of construction, Lightfoot & Wolfville Vineyard looked to obtain servicing for the building and sought extension of sewage and water services from the Town of Wolfville
- The Vineyard is nearing the second half of the build and scheduled to open by June 2017
- The vineyard will be held back for several years without the extension of services
- Options available are to partner with the Town of Wolfville or to connect with Kings County or a selfsystem for the vineyard which would see loss of acreage for growing grapes
