## MOTIONS/RECOMMENDATIONS FROM COMMITTEE OF THE WHOLE, APRIL 4, 2017

#### **VALLEY WASTE REGIONAL MANAGEMENT BUDGET**

- The Town of Wolfville provides solid waste service through an Inter Municipal Agreement with partnering municipalities/communities from Hantsport to Annapolis Royal. There are eight partners in all
- Annually the Board of VWRM approves a budget to be submitted to the funding partners for their
  approval. The formula for acceptance is not as straight forward as the Kings Transit agreement
  where a simple majority of positive votes is needed for budget approval. The VWRM agreement
  has different combinations of votes that carry the day. No one Town carries the power of veto
  and even a combination of Towns may be insufficient to offset the vote of the two rural
  municipalities, Kings and Annapolis
- Council approved the Valley Waste Resource Management 2017/18 Operating and Capital Budgets

#### KINGS TRANSIT AUTHORITY BUDGET

- The Town of Wolfville is one of four municipalities that are signatory to an Inter-Municipal Service Agreement to provide public transportation services within the County of Kings. That agreement includes a mechanism setting out the terms for decisions as they relate to specific sections of the agreement. One of these decision points is the annual operating plan/budget.
- Council approved the Kings Transit Authority 2017/18 Operating & Capital Budgets as presented at the Joint Council Meeting held February 8, 2017

## LIGHTFOOT & WOLFVILLE SERVICING AGREEMENT

- Council approved the extension of sewer services to Michael and Jocelyn Lightfoot's property and directed staff to draft a service agreement, which needs to be approved by Council
- Council approved the Service Agreement for D & M Lightfoot for the provision of sewer services, as attached in Appendix A of RFD 023-2017
