3. Presentations Acadia Athletic Complex Financial Request 2022-23

- Brian Finniss, Director of Athletics at Acadia, presented on the Acadia Athletic Complex Financial Request.
- As per our agreement the Town already provides funding.
- This \$72k request is additional and would be to assist operations with the pool.
- Council members explained some of the frustrations they are hearing from the community around lack of access to the facilities.
- Staff will look at the request and further conversations will take place at the March Committee of the Whole meeting.

4. Comments from the Mayor

- Mayor Donovan advised she and Councillor Ingham attended the official launch of the African Heritage month celebrations with Diversity Kings.
- Thanks to staff, with special mention to the Public Works staff who have done a very good job in keeping the sidewalks clear, despite the harsh winter weather we have been experiencing. Concerns continue to be received from residents in respect of accessibility. The challenges have been with the weather and staffing rather than equipment. The Town in the budget process will see if something else can be done for next year.
- Open house virtual budget meeting on Thursday. Info on website on how to join if residents have questions please participate.
- Town has received emails related to an alleged racism issue which is under review by RCMP so neither Mayor nor Council can comment, other than to acknowledge it is an important issue to all Council, staff, and Town.
- As part of the budget process, we are looking at an Inter Municipal Service Agreement (IMSA) around the Kings Diversity Initiative.
- Work continues with a police review and as we go forward, we are ensuring community policing and sensitivity to diversity are taken seriously.
- Along with Acadia we are reviewing our Memorandum of Understanding (MOU) and some of the incidents that interface with students and community.
- Council and staff are looking at ways to have appropriate community discussions on these issues.
- Councillor Granger at Diversity Kings session said something to the effect 'when we know better, we do better' believed to be taken from a Maya Angelou quote.

- 5.7.2 Payable through pre-authorized payments over a term of 5, 10 or 15 years. The Town and customer must mutually agree to the loan term before a project is authorized by the Town to proceed
