- Children's sign: Public Works advised the signage that was requested
  is not used anymore but will look at trail crossing signs for the lane
  that goes in between the houses and is used by public works vehicles.

  Board as requested. Staff have followed up with the author and
  further discussions will take place at the next meeting of the
  Accessibility Committee.
- Flags: CAO's office will review our flag bylaw and ensure we are being consistent with regard to process of appropriateness of lowering flags. Some flags have been reordered as they were not the appropriate shape and are awaiting installation.
- There is an ongoing situation with noise issues. Staff have done a great deal of work and continue to work alongside RCMP and Acadia to address these issues.
- Concern around overgrown vegetation at corner lots obstructing driver's visions. Staff have been visiting those properties to discuss the matter with the residents. A notice has been posted on the website.
- Dangerous poplar trees issue is being reviewed by staff.
- Direction required from Council whether to send letter supporting the funding of the NSNWA Resiliency Centre at Millbrook.
