P. Ricketts noted that the Town and university are trying to move forward on a number of issues around housing. Acadia's strategic Plan calls for growing the student body by 400-500 additional students. Independent living options on campus are not currently available. Initiatives are being purposed, including talking to VANSDA who have access to funding sources not available to the town or university.
