Dear Wolfville Landlords,

Thank you for your ongoing support of Acadia students as we welcomed everyone back for the 2024-25 academic year. I hope you'll agree that we are off to a strong start. I am writing today to provide you with information related to Acadia's Homecoming celebrations, and to seek your partnership in fostering a positive community atmosphere during Homecoming on October 18-20.

In addition to the many sporting events scheduled throughout the weekend (Go Axemen & Axewomen!), I'd also like to draw your attention to some of the activities designed to keep students engaged and build a sense of community:

As you can see, many engaging activities have been planned and students understand they are to behave safely and responsibly during Homecoming and all year round. However, Town Compliance staff and the RCMP will have a notable presence throughout Town beginning Friday evening in case enforcement activities are required.

We understand that as landlords you have a vested interest in avoiding the large and disruptive parties we have seen in previous years. It would be helpful and appreciated if you could reinforce Town and University messaging to set expectations for gathering and appropriate behaviour with your tenants. We have provided a sample email you may consider sending to your tenants in advance of the weekend.

We appreciate the service you provide and understand the challenges you face as landlords. With this letter I also want to emphasize the Town's commitment to work together to foster a safe and healthy community for year-round and student residents. I will also offer support: if you observe activities at your property believed to be unsafe or illegal (ie: large gathering on lawns, balconies, driveways, roofs, etc...) please call the RCMP via 911 so it may be dealt with in a swift manner.
