Specifications for 2024/2025 Bulk Salt Hauling

- Intent: The intent of this request is to provide for the transportation of bulk highway salt from the Canadian Salt Company plant at Pugwash, NS to the Town of Wolfville salt storage shed at **200 Dykeland Street**, Wolfville, NS.
- Vehicle: The contractor shall provide a vehicle or a fleet of vehicles which meet all licensing requirements of the Province of Nova Scotia and which has/have the following capabilities:
 - 1. Capacity to deliver up to a 100 tonne order within three calendar days.
 - 2. Ability to discharge the load by dumping inside the Town's storage dome
- InsuranceUpon award, the successful proponent will be required to submit current WCB Clearanceand Safety:Letter, NSCSA (or equivalent) Certificate of Recognition, \$5,000,000 General Liabilityinsurance with the Town of Wolfville named as additional insured.

Submissions must include completed Contractor Health & Safety Checklist, and successful bidder must adhere to all elements in the Town of Wolfville Contractor Health & Safety requirements (attached).

Requirements The normal requirement of the Town for salt is estimated at approximately 900 metric tonnes per year, depending on weather conditions. The Town storage bin will hold approximately 200 tonnes. The contractor will supply salt as requested throughout the winter. In no case shall the contractor delay longer than 72 hours in replenishing the bin when advised that salt is required.

The Town reserves the right to require that any or all loads of salt be reweighed before they are dumped into the bin. If a discrepancy occurs between the Salt Company weigh slip and the reweigh slip, payment will be based on the lesser amount.

Delivery Site: Proponents are encouraged to visit the Town's Public Works yard to inspect the storage dome. Make arrangements with Peter Schofield at 902-670-7433 during regular business hours to be granted access to the yard.
