Council looks forward to meeting you.</li> <li>Mayor MacKay made the following comments regarding the concerns and emails received this past week regarding closure of the Acadia Pool.</li> <li>Acadia has been clear the pool is closing. Operational costs and capital repairs that would take two years of shut down and massive financial support are noted. The reports that outline these are now on the Acadia website with the original release documents. Please to their website for this information.</li> <li>The Town is being asked to act, and we are. Starting with Seirra reports that were done in 2015 with Acadia. When those conversations moved away from being a partner, we moved on and have been working with our partners at Kings County and the Town of Kentville. The work has been ongoing since 2021 and will determine if Regional Recreation Facility is in the best interest of our residents. We are exploring this option because we know how important an aquatics facility and other amenities are to our community. The Acadia pool closing has put more urgency on the discussions with our partners at Kings and Kentville.</li> </ul>

All comments and questions are recorded and questions will be answered in CAO report for March 4<sup>th</sup> COW.</li> <li>Caroline Whitby, Maple Ave. Concerned about the pool for a while. Acadia said they can no longer commit to fund and carry the costs. The loss to the students as well as the loss from opportunities that those students could bring to the community are huge. Conversations are ongoing around housing, would like Council to work with regional partners and explore Acadia providing land on their property for whatever a new facility may look like. Community engagement in the budget process has been challenging. The Special Budget meeting was changed. Found the packages that were posted on the website were confusing. A draft operational plan was presented but not shared as part of the agenda package. Please look at how you are getting information out to the community.</li> <li>In response the CAO shared that the timeline has changed. The second version of the budget is planned to be presented to Council March 25<sup>th</sup> with approval in first week of April.</li> </ul>
