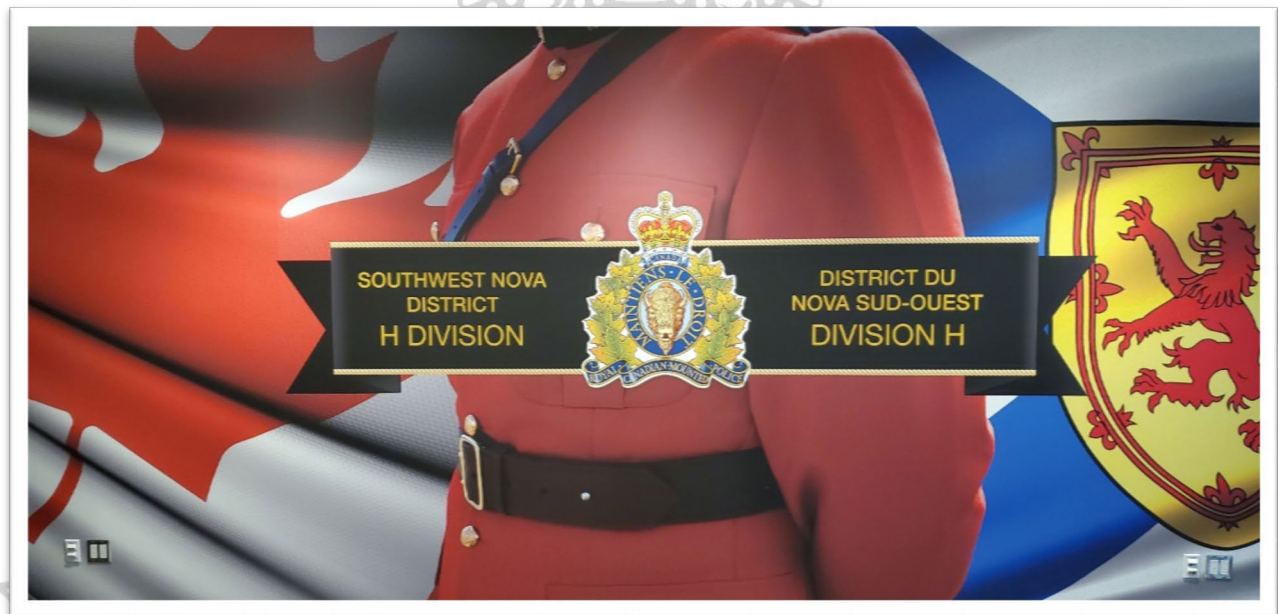

Kings District Employees

Insp. Rob Jodrey has returned in the Kings District Commander position on September 23rd, 2024.

Forty (40) general duty Constables police Kings District as first responders. These officers are supervised by eight (8) Corporals, two (2) Sergeants, and one (1) Staff Sergeant.

The Kings District Domestic Violence Reviewer position is Cst. Neil Edwards, Kings District has ten Detachment Services Assistants for the district.

School Safety Resource Officers

School Safety Resource Officers work as a resource to our local schools. Members provide presentations to every grade level from P-12 on current topics such as human trafficking, fentanyl, cybercrime, bullying, drug awareness and appropriate use of social media. Schools often request other presentations, which are customized to meet their needs. SSROs update the National SafePlan every year for each Kings County School. SSROs do the initial investigation in cases that stem from schools. SSROs also provide support for school events that occur after traditional school hours.

Cst. Wilson's service area is from Annapolis County line to Central Kings Rural High School, encompassing 11 schools. Cst. Britton's service area is from Coldbrook District School to LE Shaw Elementary, encompassing 12 schools.

With September upon us the school year has started once again. Members are continuing their school patrols and setting up in school zones to assist in keeping Wolfville students safe..

Traffic and Pedestrian Safety Reporting

Over the reporting period there continues to be an increased emphasis placed on road safety by Wolfville, Kings District, and Annapolis Valley Traffic Services RCMP members resulting in 59 Summary Offence Tickets.

Impaired driving investigations continue to be a priority for Kings District RCMP. Over this quarter there have been seven proactive check-stops focusing on apprehending impaired drivers. Five (7) impaired driving related charges.

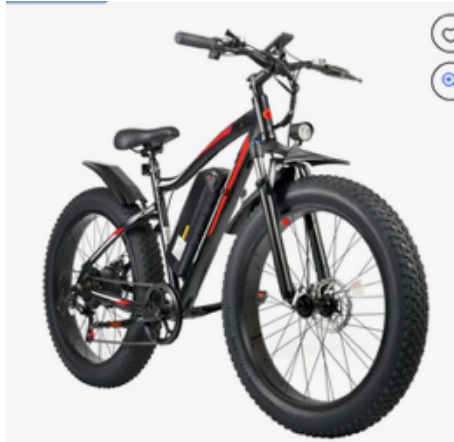
There were no reported pedestrian vs vehicle collisions during this reporting period.

Wolfville E-Scooters

There are currently 21 scooters in the town of Wolfville being operated under the business name, Wolfville Scooters. E-Scooters are regulated under the Motor Vehicle Act like a bicycle (e.g. must wear a helmet, not permitted on sidewalks, under 14 not permitted, etc). Electric Kick-Scooters fall under section 85b, 170a, 172c,d, etc. of the Motor Vehicle Act and when the EKS is operated on a roadway, the operator is deemed to be cyclist. There are stickers on the scooters that state the user: must wear a helmet and not park on sidewalks. When they finish with the scooter they have to take a picture with the app to confirm that it is left in an area that does not obstruct a sidewalk, or roadway. Customers have to sign off on terms and conditions within the app before they can actually use the scooter, and the app requires riders to be at least 16 years of age. Also attached are E-Bikes and E-Motorcycles.

The Criminal Code defines a conveyance as a motor vehicle, a vessel, and aircraft or railway equipment. The Criminal Code further defines a motor vehicle as a vehicle that is drawn, propelled or driven by any means other than muscular power, but does not include railway equipment. Battery power constitutes a means other than muscular power. An E-Scooter is therefore a conveyance as defined by the Criminal Code.

Community events

During this reporting period Kings District RCMP have not conducted any bike patrols due to the weather and availability of members. Continued foot patrols are ongoing.

During this reporting period two events were completed with very positive results. The St. Patrick's Day weekend and "Cheaton Cup" which has been renamed Spring Thaw weekend, took place. These weekend were handled extremely well due to the partnership with Wolfville town representation, Wolfville compliance and extra RCMP resources.

The Operational plans were prepared and executed with community safety being the priority. Further conversation have been had with a debrief held. More to come in the future for continued communication with all parties to continue in this positive direction.

Enforcement and ongoing Events

With spring around the corner. Bike patrols will commence and more foot patrols to continue.

As previously reported, concerns with homeless persons encampments have been addressed and is continuously monitored.
